Shepaug Valley High School, Westhill High School and Wilton High School**

On behalf of Shepaug Valley High School and Coach Fran Beilinson, Westhill High School and Coach Joe Petrone, and Wilton High School and Coach Tony Presta, I would like to invite you to attend our second tournament of the 2018-19 season on Saturday, November 16. We will follow our standard tournament format.

Please read the following items carefully:

1. We have room for all who wish to attend. However, I am concerned about getting a balanced enrolment at the three location. Too many or too few at any location makes it hard to run a good event that is fair to all.

If you plan to attend, either register on tabroom.com or else email me by Friday evening, November 8 with an estimate of how many teams you intend to bring.

SCHOOLS THAT REGISTER THE WEEK OF THE EVENT WITH NO PRIOR WARNING ARE DISCOURTEOUS TO THE HOSTS AND WASTEFUL WHEN WE OVERPRODUCE MATERIALS TO COMPENSATE.

2. You must register your teams and judges through tabroom.com . Instructions for using tabroom.com for CDA can be found here: <http://ctdebate.org/PDFs/Using%20Tabroom.pdf> . We will be using tabroom.com for registration for all tournaments.

The tournament entry on tabroom.com has nine events, Varsity, Novice and Observer for each of Shepaug Valley, Westhill and Wilton. You may choose the tournament you would like to attend by registering your debaters in the events for one high school or the other. We may ask teams that are nearly equidistant from the two hosts to switch if registrations are unbalanced.

The tournament will be open for registration on Monday, November 4 at 8AM.

4. Please abide by the rules for Novice eligibility (unchanged from last year):

The Novice division will be open to Freshman and Sophomores, regardless of experience or record. They may qualify and participate as Novices in State Finals both years. However, they may move up to Varsity at any time if they or their coach choose, and once having moved up, may not return to Novice. Coaches are encouraged to move Sophomores up to Varsity if they have been successful as a Freshman, but are not required to do so.

Juniors who have never debated before in CDA may participate as Novices in their first regular CDA tournament. Otherwise they may only debate in Varsity. They may not participate in State Finals except in Varsity. They may only qualify for State Finals while debating in Varsity.

Seniors may not participate as Novices in any CDA tournament.

5. To qualify for State Finals, a debater must win a trophy at a regular tournament, or go 3-0 at two regular tournaments. In other words, simply going 3-0 at one tournament without winning a trophy will not qualify.
